




# Archaeological Institute of America Study Leader & Guide



Dr. Nejib ben Lazreg is an archaeologist and researcher with the Institut National du Patrimoine in Tunisia. He is the Curator of the Salakta Archaeological Museum, the Lamta

Museum, and Roman sites in Tunisia's Sahel region (Leptis Minor, Thapsus, and Sullecthum). Nejib's area of specialization is Tunisia's Roman and Early Christian mosaics, though his career has also spanned other topics such as Punic, Roman, and Christian necropolises; and Roman pottery kilns, baths, and houses. He has conducted archaeological surveys in central Tunisia and excavations mainly in the Roman port cities of Leptis Minor, Thapsus, and Sullecthum, but also occasionally in the Kairouan region. Some of his major discoveries in Tunisia include an underground 4th-century Christian chapel and catacombs, and the mosaics of Venus (A.D. 300) and of the birth of Helen and the Dioscuri (A.D. 400), at Leptiminus (Lamta); the 3<sup>rd</sup>-century A.D. athletes mosaic and 6<sup>th</sup>-century A.D. mosaic-covered baptistery at Thapsus; and Christian catacombs at Sullecthum. In 2017, Nejib received the Knight of the Order of Arts and Letters medal from the French Minister of Culture; and he organized the exhibition called "Shared Holy Places: Coexistence in Europe and the Mediterranean" at Tunis's Bardo Museum, in cooperation with the Museum of Civilization of Europe and the Mediterranean of Marseille (MUCEM). Nejib was the AIA's Kress Lecturer for 2009-10, and he has led this AIA tour of Tunisia several times since 2012, to excellent reviews.

- Visit **El Djem**, one of Tunisia's most extraordinary sites, with a marvelous, 30,000-seat, ancient amphitheater and a museum that houses lovely mosaics.
- Visit the Roman city of Sbeitla (Sufetula), one of North Africa's bestpreserved Roman cities, including several stunning 2<sup>nd</sup>-century A.D. temples and mosaic-covered Byzantine baptisteries.
- Wander through **Thuburbo Majus**, a sprawling site occupied in turn by Berbers, Phoenicians, and Romans. The imperial remains include the Forum, Temple of Mercury, and sunken winter baths.

#### **ITINERARY**

Thursday, October 1, 2026: Depart home

Friday, October 2: Arrive Tunis, Tunisia | Welcome dinner Arrive today at Tunis-Carthage International Airport (TUN), where you will be met and transferred to our luxurious beachfront hotel. Enjoy a welcome dinner hosted by AIA study leader Nejib ben Lazreg and your tour manager. Four nights at the 5-star Four Seasons Hotel Tunis. (D)

**Saturday, October 3: Tunis: Bardo Museum | Carthage | Tunis** Begin the day with an introductory lecture. Then visit the world-famous Bardo, whose earliest exhibits (Punic) date to the 7<sup>th</sup> century B.C., and whose most exquisite exhibits (Roman and Byzantine) are mosaics from sites all over Tunisia, many virtually intact. After lunch we explore the vast site of Carthage, founded

in 814 B.C. by the Phoenicians and sacked by the Romans in 146 B.C. It was not until the 1<sup>st</sup> century A.D. that Rome rebuilt the city, and within a few years it expanded and prospered to the point where it was second only to Rome. Our visit of this UNESCO World Heritage Site will include the tophets (cemeteries of children), Punic ports, Antonine Baths, Byrsa Hill, and cisterns. Return to our hotel and gather for dinner. (B,L,D)

# Sunday, October 4: Nabeul Museum | Cape Bon Peninsula: Kelibia, Kerkouane | Tunis

Set out early this morning for the Cape Bon Peninsula, stopping first at Nabeul's small but interesting archaeological museum. Continue north to the coastal town of Kelibia, where we enjoy lunch. The Cape Bon Peninsula is a fertile agricultural region that was developed by the French as the heart of Tunisia's wine industry. After lunch we will enjoy scenic stops and visit the UNESCO World Heritage Site of Kerkouane, one of the most important ancient Punic cities. Return to Tunis, where the balance of the day is at leisure. Restaurant suggestions for dinner will be provided, as there are many enjoyable dining options. (B,L)

#### Monday, October 5: Oudna | Tunis: Medina walking tour

This morning we drive to Oudna (Roman Uthina), one of Tunisia's more recently excavated sites that is still a work in progress. See the fine amphitheater and nearly a dozen villas with many mosaics, cisterns, and storage areas. After lunch we return to Tunis and take an in-depth walking tour of its medina, the historic heart of the city and a UNESCO World Heritage Site, viewing from the outside the architecture of the Zitouna mosque and the nearby Hamouda Pasha and Hussein Day mosques. Return to our hotel, where we gather later for dinner. (B,L,D)



Tuesday, October 6: Dougga | Bulla Regia | Tabarka

Depart Tunis, driving through a fertile land that was part of the granary of Rome, and arrive at Dougga (ancient Thugga), Tunisia's most extensive archaeological site. Covering some 60 acres on a steep slope some 2,000 feet above the plain, Dougga was known as the "city of temples" and today is a UNESCO World Heritage Site. Visit the theater, which accommodated almost 3,500 people; the Temple of Saturn, under which was found evidence of a pre-Roman sanctuary dedicated to the Carthaginian god Baal; the Temples of Augustan Piety and Mercury; and the grandest structure—the Capitol that was dedicated to the gods Jupiter, Juno, and Minerva, and to the glory of co-emperors Marcus Aurelius and Lucius Verus. After lunch we drive to Bulla Regia, an unusual and very well-preserved site that features underground Roman

villas; a Temple of Apollo, the oldest extant structure on the site; and a 2<sup>nd</sup>-century theater. Continue driving to the seaside town of Tabarka, where we check-in to our luxurious hotel and gather for dinner. *Two nights at the 5-star <u>La Cigale Tabarka Hôtel.</u>* (B,L,D)



Enjoy a morning lecture followed by a walking tour in the coastal village of Tabarka. After lunch we return to our hotel, located along a sandy beach, to relax and enjoy its amenities. Dinner is on your own. (B,L)

#### Thursday, October 8: Chemtou Museum | Kairouan

This morning we depart Tabarka and travel to Kairouan. Along the way we visit the Chemtou Museum, which has exhibits on the quarrying and transportation of marble, a small section of the original Roman road that was used to transport the marble, and more. Once home to ancient North Africa's largest marble quarry, Chemtou was incorporated into Roman Africa in 46 B.C. We have lunch en route and check-in to our hotel in Kairouan before we gather this evening for dinner. Three nights at the 5-star Hôtel La Kasbah Kairouan. (B,L,D)

#### Friday, October 9: Kairouan: Walking tour

Kairouan's location along the old caravan routes provided a base for a flourishing crafts industry, which lives on today in its rugs and textiles. This morning, we walk through the heart of this UNESCO World Heritage Site's medina, past sellers of carpets, leather goods, brass works, and spices to the Great Mosque, which has been rebuilt several times since its original construction in the 7<sup>th</sup> century. Return to our hotel in Kairouan and then gather for dinner. (B,L,D)

#### Saturday, October 10: Sbeitla | Mactar | Kairouan

This morning we drive to the Roman city of Sbeitla (Sufetula) to see Diocletian's arch, forum, capitol, theater, and Christian churches. After lunch we visit the Roman city of Mactar to see the forum, Trajan's Arch, Caracalla's Baths, churches, and dolmens. Return to our hotel and have dinner. (B,L,D)

#### Sunday, October 11: Kairouan | El Djem | Mahdia

This morning we set out on a drive to El Djem, another UNESCO World Heritage Site and one of the most extraordinary sites in Tunisia thanks to the marvelous, 3<sup>rd</sup>-century A.D. amphitheater in the heart of the town. Nearby is the museum of El Djem, which houses some lovely mosaics and the remains of some recently excavated luxury villas. After lunch we drive to Mahdia, on the Mediterranean coast, and visit the Mahdia Museum which displays Punic, Roman, and Byzantine artifacts, and has as a section on underwater archaeology. The museum also focuses on Tunisian traditions. *Overnight at the 4-star Mahdia Palace*. (B,L,D)

#### Monday, October 12: Sousse: Walking tour, PM at leisure

We drive north to visit the UNESCO World Heritage Site of Sousse, long a thriving trading center and a major port today. Our walking tour through town will include (from the outside) the Great Mosque, originally constructed in A.D. 850; the 9<sup>th</sup>-century ribat (fortification and religious building); and the souk, which is dominated by woolworkers. After lunch, the balance of the day is at leisure to enjoy our hotel's amenities and/or explore independently the nearby city center. Dining suggestions will be provided. *Overnight at the 5-star Mövenpick Resort & Marine Spa.* (B,L)

#### Tuesday, October 13: Sousse Archaeological Museum | Thuburbo Majus | Tunis | Farewell dinner

Inside the 11<sup>th</sup>-century kasbah we tour the Sousse Archaeological Museum, which houses one of the country's best collections of 2<sup>nd</sup>- and 3<sup>rd</sup>-century Roman mosaics. From Sousse we travel inland to the vast, sprawling site of Thuburbo Majus, one of Tunisia's best-preserved sites. It was occupied in turn by the Berbers, Phoenicians, and Romans. Its imperial remains are typical of a Roman city and include the towering, 2<sup>nd</sup>-century A.D. capitol and forum. Continue on to Tunis and check-in to our luxurious hotel, conveniently located near the airport. This evening, we gather for a farewell dinner at one of Tunis' finest restaurants. *Overnight at the 5-star Sheraton Tunis Hotel*. (B,L,D)

#### Wednesday, October 14: Fly home

Transfer this morning to Tunis-Carthage International Airport (TUN) for flights homeward. (B)

MODERATE: Must be able to walk one to three miles per day on mostly flat, but often uneven, terrain.

All participants are expected to be physically active and not be an impediment to others on excursions, to enjoy traveling as part of a group, and to be ready to experience cultural differences. You must be in good physical condition to participate, and be able to make long walks unassisted over uneven terrain and up and down steps that may be steep and/or without handrails. Walking some of Tunisia's expansive sites requires being fit, and some site visits can easily last two hours. Participants who are not able to walk or stand unassisted for extended periods are kindly advised not to join this tour. If you have any questions about your ability to participate, we suggest that you visit your personal physician with this brochure in hand and discuss whether or not this program is appropriate for you. 
